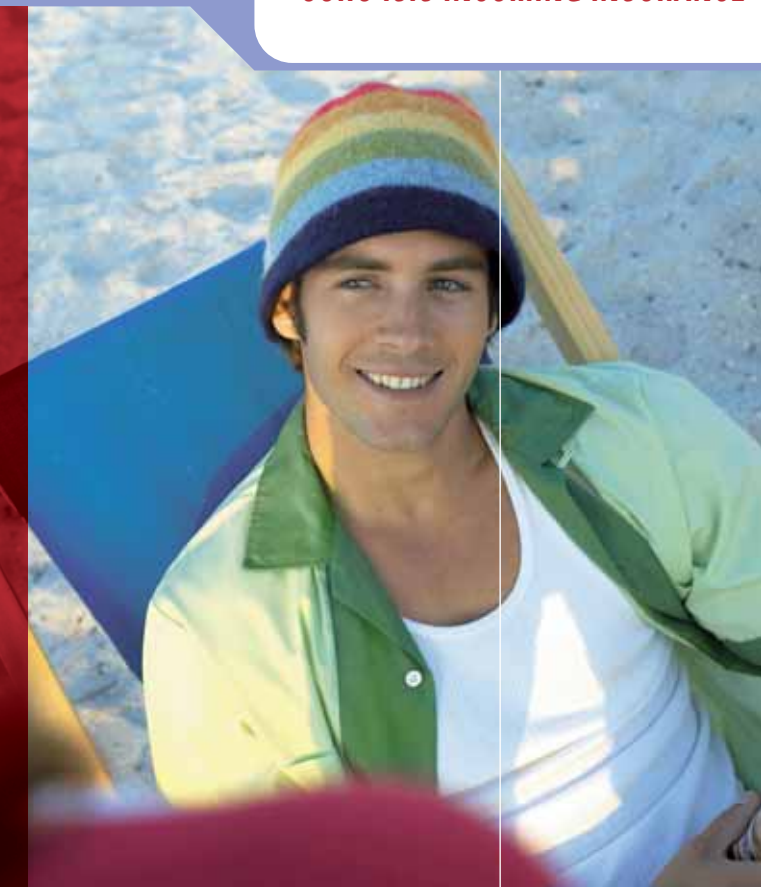

What are your options?

You can choose between 3 types of cover:

ISIS A meets your basic insurance requirements at a very competitive price and includes emergency medical expenses upto a maximum of € 70,000, the use of an air ambulance, extra travel expenses, permanent disablement, accidental death, personal liability and luggage (to and from your home country). An excess of € 100 applies to the medical and to the luggage benefit.

ISIS B includes all benefits of ISIS A but offers an unlimited cover for emergency medical expenses. An excess applies to the medical (€ 25) and to the luggage benefit (€ 75).

ISIS C offers unlimited cover for emergency medical expenses without any excess! An excess of € 45 however does apply to the luggage benefit.

Luggage All 3 types of cover can be extended with the optional luggage cover to make sure your luggage is also covered during your stay in the Netherlands and during any short trips in Europe. Excess applies as explained above.
